1 Short title

This Act may be cited as the *Appropriation (Parliament) Act* 2011.

2 Appropriation for 2011–2012

- The Treasurer is authorised to pay \$72 021 000 from the 11 consolidated fund for the Legislative Assembly and 12 parliamentary service for the financial year starting 1 July 13 2011.
- (2) The amount mentioned in subsection (1)—
 - (a) is appropriated for the financial year for the Legislative 16
 Assembly and parliamentary service to be applied to its departmental services, administered items and equity 18
 adjustment as stated in schedule 1; and 19
 - (b) includes amounts for departmental services, 20 administered items and equity adjustment delivered by 21 the Legislative Assembly and parliamentary service in 22 the financial year starting 1 July 2010 but for which it 23 has not been paid in that financial year. 24
- (3) The amount mentioned in subsection (1) includes the amount 25 already authorised by the *Appropriation (Parliament) Act* 26 2010, section 3, to be paid for the financial year starting 1 July 27 2011.
