### **1 Short title**

This Act may be cited as the *Appropriation (Parliament) Act 2011*.

### **2 Appropriation for 2011–2012**

(1) The Treasurer is authorised to pay \$72 021 000 from the consolidated fund for the Legislative Assembly and parliamentary service for the financial year starting 1 July 2011.

(2) The amount mentioned in subsection (1)—

15

(a) is appropriated for the financial year for the Legislative Assembly and parliamentary service to be applied to its departmental services, administered items and equity adjustment as stated in schedule 1; and

(b) includes amounts for departmental services, administered items and equity adjustment delivered by the Legislative Assembly and parliamentary service in the financial year starting 1 July 2010 but for which it has not been paid in that financial year.

(3) The amount mentioned in subsection (1) includes the amount already authorised by the *Appropriation (Parliament) Act 2010*, section 3, to be paid for the financial year starting 1 July 2011.
